Aim

To provide holistic, person centred, integrated and cost-effective clinical care and psychosocial support.

Benefits

- Supporting people to develop meaningful, self-directed plans based on their identified needs, interests and aspirations.
- Working with individuals to identify what works for them and how this could be enhanced.
- Linking people to the services and supports they need, and helping them navigate the system.
- Providing information, education and skills development opportunities to allow individuals to maintain their health and wellbeing.
- Encouraging people to share their experiences and coping strategies and participate in peer led activities.
- Facilitating the development of recovery orientated activities and experiences.
- Providing structured goal focused group work as well as pre- vocational groups and recreational groups.
- Working with families and carers to support them in their role providing information, and the skills they may need to maintain their own health and well-being.

Background

The Queensland Mental Health Commission estimates that one in five Queenslanders experience a mental illness or substance abuse disorder in any one year¹. Consequently, more than 85,000 Queenslanders access clinical mental health services through the public health system each year, and over 300 000 receive treatment in the private system. Timely access to a range of health and social services plays a crucial role in addressing mental health issues and can prevent acute episodes from developing into more severe long-term conditions. Currently however, adults who experience a moderate or severe mental health illness in the Darling Downs HHS region receive fragmented care which is inadequate to address their complex health and social concerns, as well as those of their carers and families. There is a need therefore for an integrated care model which provides a holistic, person-centred, 'one-stop shop' for clinical care and psychosocial support in this region. The [Integrated Care Innovation Fund](#) provides financial support to innovative projects that deliver better integration of care, address fragmentation in services and provide high-value healthcare. Funded projects also demonstrate a willingness to embrace and encourage the uptake of new technology alongside the benefits of integrating care and improving communication between health care sectors.
