Offender health record release of information guideline



1. Statement

This guideline outlines the processes and responsibilities for release of information from the Offender health primary health care record across Hospital and Health Service boundaries.

- Each HHS releases patient information according to local processes in accordance with the relevant governing legislation, and with respect to the Information access, use and disclosure standard.
- The Offender health record consists of a paper record that travels with the prisoner throughout their incarceration journey and is returned to West Moreton for storage in Central Archives upon release of the prisoner.
- Due to the movement of prisoners, the record is a state-wide clinical record that contains health information created by multiple HHS over the life of the record.
- The Health Service the prisoner is incarcerated in has governance of the health record and responsibility for access and disclosure of patient information. West Moreton Health has governance of the records on release of the prisoner and the record has been securely returned to West Moreton.

2. Scope

This guideline applies to all staff within Queensland Health. Staff refers to employees, students, interns, volunteers, contractors, consultants, Board Members and managed service providers working for Queensland Health. Queensland Health consists of:

- the Department of Health, and
- Hospital and Health Services.

Youth detention centres are out of scope for this standard.

This guideline only applies to the paper Offender health record and does not apply to any future implementation of a digital record.

3. Requirements

3.1. Principles

- **3.1.1.** Whilst the Office of the Information Commissioner states that health records are released by the HHS where they are held, this situation is unmanageable where a single paper record contains information from multiple HHS.
- **3.1.2.** By mutual agreement with the Health Information Management teams of each HHS that provide primary health care to prisoners in custody, requests for



- Offender health information will be processed by the HHS responsible for providing health services where the prisoner is currently incarcerated, with West Moreton HHS processing applications for released prisoners.
- 3.1.3. Where care is provided to a prisoner outside of a prison as an Inpatient, Emergency department patient, Specialist Outpatient, Oral Health or Specialist Mental Health patient, documentation is recorded in the hospital clinical record and requests for information will be processed according to that HHS usual release of information procedures in accordance with the relevant governing legislation, and with respect to the Information access, use and disclosure standard.

3.2. Communication of Requests

- 3.2.1. Requests for Offender health primary health care information are to be directed to the Release of Information team or Information Access Unit where the prisoner is currently incarcerated and will be processed by that HHS. Prisoners who have died in custody will be treated as current prisoners of that facility for the purposes of immediate release of information requirements related to the death.
- 3.2.2. Where a prisoner has been released, the request is to be directed to the Release of Information Unit at West Moreton HHS for processing.
- 3.2.3. Where is it not possible to check a prisoner's incarceration status or location, the request may be received by West Moreton HHS in the first instance to be reviewed and sent to the HHS where the prisoner is currently incarcerated or will be processed by West Moreton HHS Release of Information Unit if the prisoner is not currently incarcerated.

3.3. Paper record movements

- 3.3.1. When a prisoner is released from custody, or dies in custody, outstanding paperwork is to be filed and all volumes of the paper record are to be tracked and sent from the Offender health centre to West Moreton Central Archives as soon as practicable, to facilitate the timely release of information requests. Where a prisoner has died in custody, a local copy of the should may be made and kept at the facility and the original returned to West Moreton Central archives.
- 3.3.2. Where a HHS is processing a request for information, it is the responsibility of that HHS to request all paper records as are needed to satisfy the requirements of the request from either West Moreton Central Archives, or the current chart location

3.4. Processing Requests

- **3.4.1.** Requests are processed by the following facilities based on the prisoner's current location.
- 3.4.2. If there is any documentation of concern, or information that requires consultation, the processing HHS must consult the HHS the

documentation of concern originated in, as per the requirements of the *Right to Information Act 2009* s37 and *Information Privacy Act 2009* s56.

Offender health services	Primary health care services within correctional centres. The term 'prison health services' and 'prisoner health services' are used synonymously between different HHS. The term Offender health services has been adopted to describe primary health services provided within Queensland prisons
Queensland Health	The entire Queensland state based public health system, comprising the Queensland Department of Health and the Hospital and Health Services
Prisoners	An adult person incarcerated in a Queensland Correctional Centre.
